RE: FOLLOW UP ON SUBMISSION TO MARLBOROUGH DISTRICT COUNCIL FOR ANNUAL PLAN FUNDING – PROPOSED UPGRADE OF COMMUNITY CENTRE / CHANGING SHEDS AT AWARUA PARK

The Moutere Rugby Football Club has made previous submissions regarding the proposed upgrade of the Community Centre / changing sheds at Awarua Park. Refer to attached submission notes as presented to the Special Hearing Committee on 6 June 2019. It is intended that the following details are considered alongside those submission notes.

As requested, please find attached a revised plan showing the proposed changes to the Community Centre / changing sheds, being; Palatchie Architecture Design Ltd *Plan F Draft Only* dated 1/05/2020. For comparison a second sheet showing the existing floor plan is included in the same document.

In brief, the proposal:

- Is entirely within the footprint of the existing building.
- Retains public toilets.

- Creates three new separate change rooms from an existing large single room and kitchen space, refer to Change Rooms 1 – 3 on plan.
- Upgrades an existing change room, refer to Change Room 4 on plan.
- Converts an old change room into a new shower area, refer to New Showers on plan.
- Converts an old store room into a combined referees room and storage area, refer to Ref and Store on plan.
- Provides separate change room and showering facilities for female players.

Based on the attached *Plan F*, the estimated construction cost of the project will be in the region of **\$130,000.00 - \$140,000.00 plus GST**, refer to attached Construction Cost Estimate by George Guthrie Construction dated 5 May 2020.
