## Proposal for the Construction of a TigerTurf facility at the Omaka Marae

## Process

In brief, the process of building a multi-sport court consists of:

1. Site set up
2. Health and Safety establishment- including security fence and site toilet
3. All travel
4. All accommodation and staff allowances as required
5. Excavation of top soil to an appropriate depth of 150mm
6. Subgrade to be shaped to a 1% cross fall
7. Disposal of all excavated top soil on site
8. Supply and installation of a full perimeter plinth
9. Trenching for subsoil drains at 6m centers
10. Supply and installation of sub soil drains to ensure the pitch is kept a dry and free draining as possible
11. Supply and installation of specific drainage rock to cover subsoil drains to ensure drains are not blocked and kept free draining
12. Supply, load and laser grading of lower base course to maintain 1% consistent levels
13. All compaction of lower base course
14. Supply, load and laser grading of upper base course to maintain 1% consistent levels. This is the final finished layer and is critical
15. Supply and installation of TigerBond. This is a base stabilization product which is sprayed onto the finished base layer which penetrates approx. 30mm to ensure firm finish is achieved and also facilitates better drainage characteristics
16. Freight to site of other materials and tools/machines
17. Installation by our key installers, including all gluing and taping. All adhesives will be PU for strong bond
18. Line markings TBC
19. Supply, freight and distribution of sand infill to complete the surface
20. Final grooming
21. Tidy up
22. A 3x year annual maintenance contract with TigerTurf's professional in-house maintenance team (FREE)
23. A (7) year guarantee is offered on the Trophy surface. A 24x month guarantee is offered on all workmanship

- No allowance has been made for the excavation of any rock or soft spots

## Synthetic Grass Surface Options and Pricing

With all surface options there are a number of different colours to choose from, these are available at no extra charge. To build, manufacture and install the TigerTurf surface (Total Project Area) = 289m<sup>2</sup>, our price is;

### Trophy

\$69,950.00 plus GST

Trophy is a medium pile 24mm pile length (14mm actual height) polyethylene, texturized monofilament sand dressed surface. Tested ITF (FAST), Trophy is an ideal tennis surface.

Also tested to FIH (National-with pad) and English Netball AENA Category 3 requirements, Trophy is quickly becoming TigerTurf's multi use product of choice in schools and community courts. Extremely hard wearing and exclusive fibre type, it encapsulates more of the sand in-fill, producing a surface that is far less sandy in appearance and softer under foot. Trophy has a 7-year warranty.

### Timeline

Please note that our lead time for the construction of your synthetic court is 2 months. However, in peak periods (Summer holidays) a lead time of 6 months is generally required. We anticipate this project taking 6 weeks, weather depending, from confirmed start date.

### Notes / Assumptions

- The sand infill is very important. The sand TigerTurf source meets N.Z.L.T.A. specifications, and is the best product available.
- Pricing assumes very good access for all machinery and tools of the trade directly to site.
- Pricing assumes no interruptions by other contractors working on site.
- Price assumes provision of a suitable sub base. We recommend an independent geotechnical report to gain insight on specific site conditions. This can assist in mitigating the risk of sub base movement affecting pitch performance. A final submission will be prepared after evaluation of this report as soil conditions, if adverse may impact base design and add cost.

- All care, but no responsibility will be taken for machinery/truck damage to driveways and car parking entry points to the pitch construction area.
- Necessary water is available at site.
- Site location as discussed.
- No allowance for consents (do not believe any are required). If required, this is for the school to obtain. TigerTurf is happy to facilitate as much as possible.
- No allowance for Excavation of ROCK or SOFT spots or CONTAMINATED soil.
- A Site Services survey can be useful if location of these services is not known, removing uncertainty before commencement of works. TigerTurf shall not be liable for damage, disconnection or reconnection costs associated with the services that may be encountered in the area of works.
